

TOWN OF HIGH RIVER
ALBERTA
BY-LAW NO. 3622/89

Being a By-Law of the Town of High River to regulate and control the REMOVAL OF SNOW, ICE, DIRT, OR OTHER FOREIGN MATTER FROM THE SIDEWALKS in the Town of High River.

WHEREAS

Pursuant to the provisions of Section 186 of the Municipal Government Act, Chapter M-26 of the R.S.A., 1980, the Council of the Town of High River (hereinafter called the Council) may pass by-laws compelling all persons, or all persons within specified areas of the municipality, to remove and clear away all snow, ice, dirt and other obstructions from the sidewalks situated on land adjoining the property owned or occupied by them; and

NOW THEREFORE THE COUNCIL OF THE TOWN OF HIGH RIVER, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

1. This By-Law may be cited as "The High River Snow Removal By-Law".
2. In this By-Law, unless the context otherwise requires:
 - (a) "ACT" means the Municipal Government Act, Chapter M-26 of the Revised Statutes of Alberta, 1980, and any amendments thereto;
 - (b) "OCCUPIER" means that person leasing, renting or occupying that property which is described on the tax roll of the Town of High River;
 - (c) "OWNER" means that person, firm or corporation registered on the tax roll of the Town of High River;
 - (d) "PERSON" means firm, corporation or individual;
 - (e) "ROADWAY" means that portion of the highway intended for vehicular traffic;
 - (f) "SIDEWALK" means any cement or asphalt walk along the frontage of the property or where it is a corner site that portion along the frontage and that portion of walk along the side of the property.
3.
 - (a) Every occupier or owner shall be required to remove and clear away all snow, ice, dirt and other foreign material from the sidewalks situated on land adjoining the property owned or occupied by him and in the event of the failure of the occupier or owner of the said property to remove and clear away all the said snow, ice, dirt and foreign material within twenty-four (24) hours after the depositing or accumulation thereof, the Town of High River may have the work done and, in case of non-payment of the costs thereof by the occupier or owner, the cost of the work shall be charged against the property as taxes due and owing and collected as such;
 - (b) that the before mentioned twenty-four (24) hours shall mean all days except Sunday.
4. No person shall damage any sidewalk or pavement in the Town of High River by striking, picking, cutting the same, whether such person is engaged in removing snow, ice, dirt or other foreign material from the said sidewalk or pavement or not.

5. No person shall place snow, ice, dirt or other foreign material on the roadway, other than that snow, ice, dirt or other foreign material deposited thereon by Town authorized snow removal or road maintenance.
6. By-Law No. 346 and amendments thereof are hereby rescinded.
7. This By-Law shall come into effect on the Third and Final Reading thereof.
